Club Finances and banking

- G. Haeger shared that incorporation of the club was completed in the past but the corporation was dissolved after we were denied tax exempt status as a charity. We will need tax ID number for a checking account.
- M. Carroll suggested three options:
 - 1) Liquidate the current checking account and use a cash box.
 - Mary would apply for a non-profit employer number thus giving the club a tax ID number. This practice would have to be continued with future treasurers.
 - Investigate exemption as an unincorporated association under sections 23701g or 501c7. This task would be time consuming and some cost associated with it.
- P.K. O'Hern also investigated the incorporation process and shared his prior experience with the cumbersome process.
- Discussion from the group began to investigate how other car clubs handle their finances. J. Parker belongs to three car clubs and they are all handled differently.
- The group discussed increasing the annual insurance up to 10 million to protect club members.

- Geoff will research costs for increasing insurance to 10 million per year.
